SECOND ROUND OF CONCLAVE OF RSETI DIRECTORS

In compliance with the MoRD guidelines to organize a 2-day Conclave of their RSETI Directors as an annual event, Bank of Baroda, Canara Bank, Dena Bank and Punjab National Bank organised the Conclave for their RSETI Directors in the previous quarters. During this quarter, Andhra Bank, Indian Bank, Indian Overseas Bank, State Bank of Hyderabad, SyndicateBank, UCO Bank, Associate Banks of State Bank of India and United Bank of India also took the initiative in organizing Conclave for their RSETI Directors.

A SOURCE OF INSPIRATION TO SCHOOL DROPOUTS

A Success Story from ABRSETI, Hazaribag, Jharkhand State

For any school dropout, the future looks bleak, especially if he does not have aspirations to take up any income generating activity by which he can earn his livelihood. This was not so in the case of



Mr. Tapeswar Prasad.

Being a son of a poor villager, Tapeswar Prasad was considered a burden on the family just because he could not study well and was branded a 'school dropout'.

But Tapeswar Prasad had the aspiration to do one or the other activity not only to keep himself engaged but to explore the possibility of earning a decent livelihood from the activity. One day during the year 2002, while he was with his friend, Tapeswar Prasad came to know about various training programmes being organized by Birsa Munda Institute for Entrepreneurship Development sponsored by Allahabad Bank in Hazaribag, Jarkhand State. His friend, who had gathered information about this Institute, advised Tapeswar to meet the Director of the Institute to personally know about the activities of the Institute and to benefit from the same.

Mr. Tapeswar Prasad, eager to see whether any training will help him, personally visited the training centre, spoke to the Director and discussed various training programmes offered by the Institute. When Tapeswar was confused as to what kind of training will suit him, the Director, after studying the aptitude and skills of Tapeswar, suggested that he should go for training on "Radio & Television Repair," which was a most popular programme during 2002.

The 30-day training programme on "Radio & Television Repair" helped Mr. Tapeswar Prasad to not only develop the skills in repairing/servicing Radio and Television sets, but also in gaining confidence to start a self-employment venture. Thus, Tapeswar Prasad started a small Radio and TV repair shop immediately after the training programme. His courteous behavior with the customers, quality of service offered and his sincere approach helped him see gradual growth in the business. As the technology changed and the radios started phasing out, Mr Tapeswar Prasad slowly switched over to business in electrical goods and today, he is not only selling electrical goods, but also servicing Television sets in his small shop, thus earning a net profit of Rs. 10,000/- per month.

Mr. Tapeswar Prasad is no more a burden in the family. On the other hand, he is a source of inspiration for the unemployed youth in the village. Even after 10 years, he proudly recalls the excellent inputs he got in the training at Birsa Munda Institute for Entrepreneurship Development and says, "30-day training at the Institute has changed my life forever. I am ever grateful to the RSETI for what I am today".

PHYSICAL DISABILITY NO BAR FOR SUCCESS

A Success Story from Andhra Bank RSETI, Rajahmundry, Andhra Pradesh

The secret behind the success of an enterprise is the entrepreneur. An idea that an entrepreneur generates, how he implements the idea, the competencies he possesses to take the enterprise forward, his attitude, confidence, etc.



matters the most in the success of an enterprise. Thus the key to success lies with the entrepreneur irrespective of whether he is a normal human being or a physically challenged person.

Here goes the story of Mr. Dharnala Sathi Babu, a physically challenged youth. Mr. Sathi Babu hails from a small village in East Godavari District of Andhra Pradesh. His father, a mason earning a meager daily wage, had a difficult time in providing a good-quality education to the four children in the family. With great difficulty Sathi Babu could complete his graduation and started working as a Data Entry Operator in a small establishment at Hyderabad. Though he had good offers from other employers, Sathi Babu could not take advantage of them because of difficulty in his mobility. While working as Data Entry Operator, one of his friends by name Mr Shiva informed Mr Sathi Babu about the activities of Andhra Bank RSETI, Rajahmundry where varieties of training programmes are offered free of cost to the unemployed youth to take up self employment. Mr Sathi Babu, on visiting the RSETI was impressed with the activities of the Institute and requested the Director to provide him a training on Multiphone Servicing. After selection process and interview, Mr Sathi Babu was selected for the training programme and it was an innovative experience for Mr Sathi Babu since he could learn the various skills of mobile repairs apart from soft skills like marketing and business techniques, communication skills, entrepreneurship competencies, etc. which helped him to gain confidence in taking up self employment despite his disability.

On completion of the training programme, arranging funds to take up self employment was a challenge for him. He thus decided to start off with a humble capital from his house itself and it was indeed a surprise for his friends and relatives that a business on mobile servicing can be started from the residence also. His hard work and commitment towards the customers coupled with timely servicing paid rich dividends to Mr Sathi Babu and in a matter of one year he made use of his experience of working as a Data Entry Operator and started "New Data Point" with his two friends along with mobile servicing. Today, with Mr Sathi Babu as Managing Director and his two friends as Directors of "New Data Point" they are taking up various online projects. Their timely completion of projects has helped in getting more business and hence they have appointed 10 Data entry operators who work in two shifts in five systems. After paying salary of Rs. 3,000/- each to ten Data Entry operators, Mr Sathi

Babu and his partners are presently able to earn more than Rs. 10,000/- each per month which, in no way, is a small income for Mr Sathi Babu. With full of confidence in his business activity, Mr Sathi Babu is hopeful that he and his partners will be able to earn Rs. 30,000/- per month in the next 5-6 months. Today his father is very proud of his son who is able to earn more than a normal person. Mr Sathi Babu, besides his Data entry business, is pursuing his mobile servicing unit for which State Bank of India has sanctioned him a loan of Rs. 60,000/-.

Besides this venture he is establishing a Cell Point at Kothapeta for which State Bank of India, Kothapeta has sanctioned a loan of Rs.60,000/-, Mr. Sathi Babu is also involved in social work and helping the physically handicapped (PH) persons in the District as a convener of PH Society. Now, Mr Sathi Babu has become a source of inspiration for hundreds of unemployed youth Kudos.

GROW MUSHROOM AND GROW IN BUSINESS

A Success Story from SBI RSETI, Deoghar, Jharkhand



Mr Shiv Pratap Singh, right from his childhood, was not much interested in studies. His father, a retired Sub Inspector of Police was very keen that his son should study well and go for a Government job. He thus motivated his son to study well but Mr Shiv Pratap Singh, with

great difficulty, studied up to BA. His father was very proud that Mr Shiv Pratap Singh became a graduate and he would settle down in his life by taking up some Government job. With a degree in hand, Mr Shiv Pratap Singh went around many places in search of a job, but he could not succeed.

As the days passed, Mr Shiv Pratap Singh realized that just a degree will not help and hence he started a small business of supplying building materials by hiring a Tractor. Though he found the business profitable, much of the expenditure went towards diesel and hiring charges of the Tractor. In the meantime, his parents were worried that the age of Mr Shiv Pratap Singh was advancing and hence they convinced him to get married. After the marriage, his responsibility increased and the income from his business was not sufficient to meet the daily needs of his family. Thus Mr Singh thought of taking up some more activity by which he could supplement his earnings.

At this point of time, while discussing his plans, one of his friends suggested to Mr Singh that he take up some training in self-employment at SBI RSETI, Deoghar, which is very close to Mr Shiv Pratap Singh's house. Though Mr Singh had watched some young boys and girls undergoing training at RSETI, Deoghar he never thought of enquiring as to how the training will be of use in taking up self-employment activity. Since there was a dire need of enhancing his income, Mr Shiv Pratap Singh visited the RSETI and collected all

the details of the training programmes conducted at the Institute. During his discussion with the Director of the Institute, he came to know that a training programme on Mushroom Cultivation was going to begin soon. Mr Singh was happy to understand from the Director that Mushrooms are in great demand in the market and the same can be cultivated by investing a humble capital in the house itself in a small room. As there was a cowshed in his house, Mr Singh thought of utilizing the same and hence he enrolled his name for the training programme on Mushroom Cultivation.

The training programme was an eye-opener for Mr Shiv Pratap Singh as he could learn many things apart from mushroom cultivation like the entrepreneurial skills, customer management, problem solving skills, etc., which boosted the confidence of Mr Singh to take up the activity immediately. Thus he started the activity in a small cow shed in his house itself and personally carried the products to Hotels and Restaurants where the mushrooms are in good demand. Within a short period of six months, the demand increased manifold and the end users started picking up the product from the residence of Mr Shiv Pratap Singh itself. This helped Mr Singh to save time and money to go to the market to sell his products.

Mr Shiv Pratap Singh is a very happy man today. He has studied the market requirement of mushroom products and accordingly he has added other products like mushroom pickles, chatni, nuggets, etc., which are purchased by the nearby households and hoteliers. All these have supplemented the income level of Mr Shiv Pratap Singh and he proudly says that he is able to earn approximately Rs. 8,000/- per month by Mushroom cultivation alone. Looking at the demand for his products Mr Shiv Pratap Singh has future plans of expanding his business by constructing one more room in his house.

श्रीमती मुकेश पति श्री रोहताश सोनीपत के गांव गढी झंझारा के एक गरीब परिवार की विवाहिता औरत है, जो कंपल सातवीं कक्षा तक पढ़ी है और पति घर से दूर कहीं महीना का कार्य करता था क्योंकि उसे और कोई कार्य नहीं आता था तथा पति के दूर होने के कारण घर की सभी समस्याओं से उसे अपने आप ही लड़ना पड़ता था और अपने परिवार की कमजोर आर्थिक हालत से दिन प्रतिदिन कुछ न कुछ समझौता करना पड़ता। इससे निकलने को उसे कोई रास्ता नहीं दिखाई दे रहा था, किन्तु श्रीमती मुकेश इन समस्याओं से किसी भी कीमत पर निकलना चाहती थी। तभी एक दिन उसकी नजर अखबार पर पड़ी और उसने पढ़ा कि पंजाब नेशनल बैंक, ग्रामीण स्वरोजगार प्रशिक्षण संस्थान, सोनीपत की ओर से विभिन्न प्रकार के प्रशिक्षण शिबिरों का आयोजन निशुल्क किया जाता है। श्रीमती मुकेश के मन में उम्मीद की किरण लगी और उसने प्रशिक्षण लेने की टान ली और वह संस्थान पहुँच गई, जहाँ पर संस्थान के अधिकारियों/कर्मचारियों द्वारा विभिन्न प्रशिक्षणों के बारे में बताया गया, जिसमें से उसने हैंड निटिंग के प्रशिक्षण के लिए अपना फार्म भरवा दिया और प्रशिक्षण प्राप्त करने लगी। श्रीमती मुकेश मन ही मन खुश हुईं और सोचा कि काश यह मौका मुझे 6-8 साल पहले मिला होता तो मेरे पति को काम के लिए घर छोड़ कर न जाना पड़ा होता, पर अभी भी देर नहीं हुई है। मैं अपनी मेहनत और लगन से कार्य करके अपने पति को वापिस बुला लूंगी और दोनों मिल कर आजीविका के साधन वहीं जुटा लेंगे। प्रशिक्षण प्राप्त करने के दौरान ही श्रीमती मुकेश ने अपनी लगन का परिचय दिया और सब बड़ी बारीकी से सीख लिया। प्रशिक्षण प्राप्त करने के बाद उनके इरादे के साथ काम शुरू कर दिया। आज श्रीमती मुकेश ने अपनी मेहनत से अपनी कमाई शुरू कर दी। दिन रात की मेहनत के बाद मुकेश घर पर ही अपना कार्य करके बैंक के ऋण की किरत अदा करने के बाद 8000/- से 9000/- रुपये हर

महीना कमाई कर रही है, जिससे उसके घर में खुशियों का माहौल है। श्रीमती मुकेश 2-3 लड़कियों को इसका प्रशिक्षण भी दे रही हैं और वह चाहती है कि उसकी दोनों बेटियाँ भी यह काम सीखें और आगे जा कर इसी में अपना भविष्य बनाए। अब श्रीमती मुकेश के पति को काम की तलाश में बाहर नहीं जाना पड़ता है। वह श्रीमती मुकेश का हाथ इसी कार्य में बटाता है और खुश है। अब श्रीमती मुकेश चाहती है कि वह अपना खुद का हैंड निटिंग सिलाने का कार्य शुरू करें ताकि समाज से बेरोजगारी दूर हो सके एवं ज्यादा से ज्यादा महिलाएँ अपने पैरों पर खड़ी हो सकें।
